Once the confirmation report is received, an invoice will be generated for payment.

The cost this year is the same as it has been for the past three years. We appreciate the staff at the Holiday Inn for working with us to keep this trip affordable for our students. The cost for Students - \$130.00 Advisor Double - \$185.00 Advisor Single - \$230.00 (The MD Agricultural Fair Board has contributed \$70/FFA member/advisor to help defray expenses)

Rooms are available for check in on Thursday, Sept. 15th after 3:00 pm and check out on Saturday, September 17th. Should you need to stay through Sunday, September 18th there is an additional cost of \$110/room for Saturday night and you, the Advisor, must indicate the need for the room(s) on your Chapter's confirmation report. Breakfast will be provided at the hotel each morning along with the awards dinner on Saturday night. You and your students will be responsible to cover the cost of additional meals, incidentals, travel to and from the hotel and to The Big E grounds. Please note: You must arrange for your own transportation for the Big E events from your home chapter.

## 1. Advisors must register their teams online at www.judgingcard.com

To log onto judging card, use your chapter number as both the login and password. (ex. MD0000) You will need to enter the student name and their FFA membership number. You can access the student numbers by logging into your advisor portal on <u>www.ffa.org</u> and viewing your Chapter roster. (**Do not pay the registration fee online for each team/individual. It is already included in the student cost for registration**).
