The conference will be held this year at the River Valley Ranch on **Friday, October 12 through Sunday, October 14, 2018**. The camp is located at 4443 Grave Run Road, Manchester, MD 21102. Phone number is 443-712-1010. Arrive by 5:00 pm on Friday, and depart on Sunday at 11:30 am.

This is a great opportunity for your chapter officers to enjoy the beautiful outdoors as they get to know other chapter leaders in Maryland, develop their personal leadership skills, build team unity and create a master plan for their chapter activities.

Through the generous support from CSX, and the Maryland FFA Foundation, the cost to attend COLT only \$85 per member and \$100 per advisor and/or chaperone. The cost includes:
